Minutes of Meeting of XXVI [26th] Annual General Body Meeting (AGBM) of the Academy of Hospital Administration (AHA) held **on 20th Dec 2024 at 18:00-19:00 hrs.** at Constitutional Club of India, Rafi Marg, New Delhi on the sidelines of SASH 2024.

A total of 26 members attended the AGBM. It was followed by dinner for all the members.

In the absence of the President and Vice President, the AGBM was chaired by Dr. Shyama Nagarajan, Executive Director (ED) of, the Academy of Hospital Administration.

AGENDA POINTS

1. Opening Remarks by Executive Director(ED)

- As the quorum was not present, the AGBM was adjourned for 10 mins and resumed with due permission of members. The Annual General Body Meeting commenced thereafter.
- At the beginning of the meeting, ED requested all the present members to stand and observe 02 minutes silence in order to pay respect on behalf of AHA to the two departed members in the current year -Surgeon Rear Admiral (Dr.) V.K. Singh, VSM (Past President 2006-08) and Dr. Anoop Kumar Daga, Vice President BoE 2022-24
- ED then proceeded to extend a warm welcome to all the members present for the meeting. She then
 presented the AHA Annual Report 2022-24. It provided an overview of the organization's activities over the
 past two years and highlighted the notable accomplishments as detailed in Section 3 on the Annual
 Report.

FD outlined the primary sources of income for AHA House:

- 1. **Programs** While these are intended as a major revenue source, there is currently no significant income from the programs.
- 2. **MBA-HM Program** This is the principal revenue driver. FD commended the MBA faculty for their efforts and contributions to this program.
- 3. AHA Memberships Memberships contribute to the income stream.
- 4. Miscellaneous Activities These include initiatives such as JAHA and short courses lasting 3-5 days.
- 5. **Rental Income**. From the 03 floors of the second building on rent
- 6. **New Projects** Two projects as mentioned in Para 2 (g) above have recently been completed, representing additional efforts to build an additional revenue stream and enhance income

Key Expenditures

The main expenses highlighted were:

- Salaries
- Program expenses
- Administrative expenses
- Repair and Maintenance
- Energy expenses
- Utilities
- Miscellaneous expenses

iii) Audit Objection: It has been observed that a few Regional Chapters are not sharing adequate financial data, although they use PAN/GST no. of HQ AHA. This can be construed as major irregularity by the auditors of AHA. It can lead to legal / punitive action for the AHA. Therefore, AHA has created mother account at HQ AHA with HDFC and child accounts with all regional chapters with view rights, so that expenses can be seen and accounted for centrally. The Child account holders, i.e. the regional chapters have to only start operating through this account for all AHA related activities. Detailed letter to operationalize this arrangement would be initiated by the Accounts AHA

3. AHA Elections BoE 2025-2027

ED informed the AGBM about the consultations and advice taken by the BoE 2022-24 from Maj Gen R K Garg, AVSM (Retd), and Chairman of the Election Committee as regards the conduct of elections, which was documented in the 19th BoE meeting held on 27th July 2024. ED briefed that for the seamless conduction of SASH 2024 and to bring back the BoE term cycle to sync with the financial year of the Govt of India.

After detailed deliberations, the members agreed to announce the elections to be held in mid-Feb 2025 with

the Handing Over – Taking Over(HO/TO) to commence with the announcement of the election results and completed by 31 Mar 2025. This would enable the newly elected BoE to be effective from 01 Apr 2025. The voting dates were accordingly worked out **16 to 20 February 2025** considering the statutory time required for all the pre-voting activities in the election process.

It was decided that as in the past this AGBM minutes will be shared as password protected file on the AHA site for reference related to elections.

3. Revenue Generation for AHA

The ED and FD emphasized that in view of the precarious financial status of AHA it is critical that members, especially those who are office bearers at the national and regional levels, make strong commitments and take initiatives for developing new programs, and conducting them regularly with due efforts for operationalizing the same in the long term. The point of deliberated at length and it was clarified by the FD that the efforts in this regard is totally lacking, and needs some serious positive steps to be taken to safeguard the brand AHA as premier training institute and sustain operations. The FD further emphasized that in case of AHA a new program development and operationalizing it means rolling up sleeves and coordinating with required stakeholder to get the programs off the ground and run with it.

5. Role of AHA in Advocacy of Hospital Administration as a specialty

Dr. Mahesh Devnani, Prof and HOD AIIMS, Jodhpur raised the issue related to the advocacy of Hospital Administration as specialty with relevant centre and state level bodies, for ensuring that the Medical Superintendent Positions in all public Hospitals are met with by qualified Hospital Administrators. The point was deliberated, and it was explained to the members that while AHA is ready to take up such issues around advocacy, the concerned person raising the point would need to be the focal point for coordinating with relevant stakeholders for preparing the requisite background documents to be duly submitted for such consideration, keeping in mind the requirement of different levels of healthcare facilities and the number of production of qualified administrators in the country. This is because, AHA per se does not have any such specialist hired/ appointed to prepare notes of such depth and complexity. If required the concerned sponsor/s of the point would be called to HQ AHA by the BoE for participating in such meeting at the state or the national level as deemed necessary.
